Thence, southwestwardly along the southeast line of St. Ferdinand Commons Fields subdivision to the south corner of a 26.75 acre parcel formerly owned by Joseph and Marie Desloge H/W, currently owned by the City of Florissant (St. Louis County Locator # 05K120013);

Thence, North 34 degrees 36 minutes West 300 feet to a point;

Thence, South 37 degrees 44 minutes West 112 feet to the north line of Flamingo Park Plat 6;

Thence, southeasterly along the north line of Flamingo Park Plat 6 to its intersection with the northwest corner of Flamingo Park Plat 5;

Thence southeasterly along the north line of Flamingo Park Plat 5 to its intersection with the northwest corner of a parcel owned by Hazelwood R-1 School District (St. Louis Locator # 06K240475);

Thence southeastwardly along the southwest ROW line of Central Parkway to its intersection with the northwest ROW line of Shackelford Road;
