Staff Report – Ms. Dougherty stated that it has been very quiet at the Boundary Commission these days.

Mr. Hamilton reported that the appeals court upheld the lower court's decision and sent it back to the Boundary Commission to forward to the Election Board for an election. At issue was whether or not the proceeding before the Boundary Commission was a contested case or a non-contested case? They found for two reasons that it was a non-contested case – the Boundary Commission procedural formalities didn't make it a contested case and the proceeding didn't determine the rights of specific parties. The appeals court relied on a Michigan case but also stated this was a case of first impression. Mr. Hamilton stated the Boundary Commission did have options and would discuss those in closed session.

Ms. Schuman asked if everything was okay with the Boundary Commission lease since the building had been sold. Discussion ensued about keeping in mind that the Boundary Commission lease expires in May 2009.
