# BOUNDARY COMMISSION ST. LOUIS COUNTY, MISSOURI MEETING MINUTES

July 27, 2010

#### ROLL CALL

Roll was called and a quorum declared by Ms. Dougherty.

#### APPROVE AGENDA

Ms. Schweitzer made a motion to approve the agenda. Mr. Ford seconded the motion. Voice vote: Ayes, All. Nays, None. *The motion passed*.

#### APPROVE MINUTES

Mr. Ford made a motion to approve the minutes as corrected. Mr. Wojtkowski seconded the motion. Voice vote: Ayes, All. Nays, None. *The motion passed*.

Staff Report – Ms. Dougherty's report was included in the monthly meeting packet.

There was no public comment.

### **NEW BUSINESS**

### A. 2011 Budget

Mr. Ford presented the 2011 budget as developed by the budget committee. The total is \$171,964. It is a 5% decrease over the 2010 budget per St. Louis County's request. Mr. Ford stated the committee had been sensitive to the economic situation and made reductions in areas that would not affect the Commission's ability to carry out its duties. However, Mr. Ford stated that next year's budget might show increases in those areas because the Commission will be entering the start of the Map Plan cycle and, typically, the Commission incurs more costs during that budget year.

Mr. Wojtkowski made a motion to approve the 2011 budget as presented by Mr. Ford. Mr. Freesmeier seconded the motion. Voice vote: Ayes, All. Nays, None. *The motion passed.* 

B. BC1002 – Valley Park "Southwest Equestrian Area" – Accept Proposal & Set Public Hearing. Discussion ensued about whether the proposal met the contiguity requirement. Ms. Fiegel said they were looking at that in depth at the planning department. Ms. Schweitzer made a motion to accept proposal BC1002. Mr. Freesmeier seconded the motion. Voice vote: Ayes, All. Nays, None. *The motion passed*.

Mr. Ford made a motion to set the public hearing for BC1002 as Thursday, September 9, 2010 at 7 p.m. at Valley Park High School Library. Mr. Wojtkowski seconded the motion. Voice vote: Ayes, All. Nays, None. *The motion passed*.

C. BC1003 – Valley Park "Unincorporated Pocket" – Accept Proposal & Set Public Hearing. Mr. Ford made a motion to accept proposal BC1003. Mr. Freesmeier seconded the motion. Voice vote: Ayes, All. Nays, None. *The motion passed*.

Mr. Wojtkowski made a motion to set the Public Hearing for BC1003 on September 9, 2010 at 8 p.m. at Valley Park High School Library. Mr. Ford seconded the motion. . Voice vote: Ayes, All. Nays, None. *The motion passed*.

D. BC1004 – Grantwood Village "Area B" – Accept Proposal & Set Public Hearing. Ms. Schweitzer made a motion to accept proposal BC1002. Mr. Wojtkowski seconded the motion. Voice vote: Ayes, All. Nays, None. *The motion passed*.

Mr. Freesmeier made a motion to set the Public Hearing for BC1004 on Tuesday, September 14, 2010 at 7 p.m. at location to be determined later but near the targeted area. Mr. Wojtkowski asked if the Commission would still have its regular meeting in September. The Commissioners discussed moving the regular meeting up to September 14<sup>th</sup> as well. Mr. Ford seconded the motion. Voice vote: Ayes, All. Nays, None. *The motion passed*.

A. BC1001 – Florissant "Area 13" – Answers to Completeness Review. Ms. Dougherty wanted to make sure that everyone had a copy of the answers to completeness review that Florissant had submitted. And to remind everyone that the Public Hearing for BC1001 is set for August 24, 2010 at St. Angela Merici School gymnasium following the regular Boundary Commission meeting at 6:30 in the same location.
