December 17, 2013

FINANCIAL REPORT – Year End Budget

Ms. Dougherty stated that the Commission is on target to finish under budget around \$60K per usual.

STAFF REPORT

Ms. Dougherty stated she had been working with Ferguson on answering questions they have regarding their plan of intent. Ms. Dougherty also pointed out that the Commission members have in their packet the dates for 2014.

Ms. Dougherty stated that the Joint Interim Committee's report on the St. Louis MSA Governance and Taxation was in the meeting packet. Ms. Wilkerson asked if the JIC wanted to abolish the Boundary Commission. Ms. Dougherty stated that from her discussions with Tom Curran at the County Executive's office, it seemed more so that there wasn't a good understanding of what the Commission does. Chairman Sauerwein concurred that was the message he received from State Senator Eric Schmitt when he spoke with him about the report. Chairman Sauerwein also offered to Sen. Schmitt the Boundary Commission services in answering any questions they might have. Ms. Dougherty stated she made the same offer to Tom Curran.

Mr. Carr inquired as to whether Ferguson was moving forward with their annexation proposal. Ms. Dougherty replied that Ferguson said they were working on their feasibility study and evaluating the fire district costs and that she referred them to St. Louis County Planning Department for additional assistance with the tax information required in the plans of intent. Discussion followed regarding the fire district provision in the Boundary Commission statutes.

PUBLIC COMMENTS

Justin Carney stated he has been in contact with Ferguson to answer questions regarding taxes.
