#### **NEW BUSINESS**

### A. New Office Lease

Ms. Dougherty shared the two proposals: 230 S. Bemiston and 225 S. Meramec. Mr. Dorsey asked for Ms. Dougherty's recommendation. She stated she preferred 225 S. Meramec over 230 S Bemiston because of the layout, the incentives, the amenities, the high amount of natural light. Chairman Schweitzer said \$19/sf was good for Class A office space compared to the \$28/sf the Boundary Commission currently pays. Mr. Dorsey requested a draft lease for the Commission's attorney

to review and once Mr. Hart approves that the Commission can hold a special meeting to approve the final lease.

Mr. Hart suggested the Commission add a clause about the possibility of lawsuits eliminating the Boundary Commission terminating the lease. Ms. Dougherty stated they had tried to add those amendments to the last lease renewal and the landlord couldn't comprehend that idea, so they just signed the renewal without the clause. Chairman Schweitzer said it didn't hurt to ask.

Chairman Schweitzer directed Ms. Dougherty to get the sample lease to distribute and to set up a special meeting to approve the lease once Mr. Hart had a chance to review it.
