ADOPTING A MAP PLAN FOR SUBMISSION TO THE ST. LOUIS COUNTY BOUNDARY COMMISSION AND AUTHORIZING THE MAYOR TO ACT ON BEHALF OF THE CITY IN TRANSACTIONS WITH THE ST. LOUIS COUNTY BOUNDARY COMMISSION REGARDING THE MAP PLAN AND RELATED ANNEXATION MATTERS

WHEREAS the City Council has determined that the submission of a Map Plan for the potential annexation of certain unincorporated areas of St. Louis County is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BLACK JACK, ST. LOUIS COUNTY, MISSOURI AS FOLLOWS:

<u>SECTION 1</u>. Pursuant to RSMo §§ 72.400—72.433, the City Council hereby adopts the Map Plan, attached hereto as Exhibit A and incorporated herein by this reference, as the Map Plan of the City of Black Jack for submission to the St. Louis County Boundary Commission.

SECTION 2. The City Council hereby authorizes and directs the Mayor of the City of Black Jack to submit such Map Plan to the St. Louis County Boundary Commission and to act on behalf of the City of Black Jack in transactions with the St. Louis County Boundary Commission related to the potential annexation of the areas depicted on the Map Plan.

SECTION 3. This resolution shall become effective upon its passage and approval by law.
