Re: July 1, 2006 Proposed Boundary Adjustment Map Submission

Dear Ms. Irwin,

Enclosed please find twelve paper copies and one digital copy of the proposed boundary adjustment map plan for the City of Lakeshire which is due July 1, 2006.

The area under consideration by the City for possible annexation is the unincorporated section indicated on the map by light yellow shading. Heading north along Tesson Ferry Road from the City's northeast municipal boundary, the area is bounded on the east by Tesson Ferry Road and extends north to Gravois Road. Gravois Road becomes the north boundary as the proposal turns and heads west along Gravois Road to Musick Road. Musick Road becomes the south boundary as the proposal then heads east on Musick Road to Tesson Ferry Road and then north along Tesson Ferry Road to connect with the City's southeast municipal boundary. Please note that the City has not included Tesson Ferry Road, Gravois Road or Musick Road in its proposed boundary adjustment.

Per the Map Plan Submission - Information Sheet and RSMo. §§72.150-72.220 and §72.420, nothing has been indicated in terms of a potential consolidation with other surrounding municipalities on this map.

Also enclosed is a resolution passed by the City of Lakeshire Board of Aldermen which is submitted as certification that the attached map plan represents the official map plan proposal in conformance with the requirements of RSMo. §72.423 (1999 Cum. Supp.). The designated official who has the authority to act on behalf of the City is Mayor Maria V. Unger..

Should you have any questions or concerns about this matter, please do not hesitate to call me. Thank you for your assistance and guidance concerning the process for submission of this proposed boundary adjustment.


Be it resolved by the Board of Aldermen of the City of Lakeshire, Missouri, as follows:
