RESOLUTION NO. 2000-610

A RESOLUTION APPROVING A GENERAL MAP OF PROPOSED BOUNDARY CHANGE FOR THE CITY OF MARYLAND HEIGHTS

WHEREAS, the Boundary Commission of St. Louis County has adopted new rules for all boundary changes for incorporated municipalities; and

WHEREAS, a General Map of Proposed Boundary Change must be filed with the St. Louis County Boundary Commission or no boundary changes may occur within the city for a minimum of five years; and

WHEREAS, the General Map of Proposed Boundary Change must be filed by July 1, 2000; and

WHEREAS, there exists lands located within unincorporated St. Louis County along the Page Avenue Extension that may warrant consideration for annexation into the City of Maryland Heights;

NOW, THEREFORE, be it resolved, that the City Council directs the City Planner to file on behalf of the City a General Map of Proposed Boundary Change, as attached (Exhibit A).
