
WHEREAS, the City of Moline Acres is desirous of extending its boundaries by annexing an unincorporated area which is contiguous to the present city boundaries, and

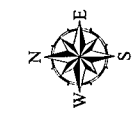
NOW, THEREFORE, be it resolved by the Alderpersons of the City of Moline Acres as follows:

2. The Mayor is further authorized and directed to provide the Boundary Commission with any and all information, documents or material required by the Boundary Commission in regard to this proposed annexation.
3. A copy of the map of the **City of Moline Acres** and the **Proposed Annexation**, dated June 1, 2000, shall be kept on file in the Office of the City Clerk for public review and inspection.
