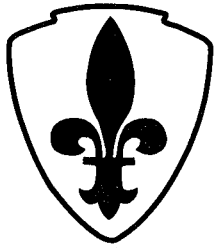
This proposed annexation would be of mutual benefit to the city and the residents of the retirement home. We would appreciate your prompt attention and approval of this proposal.

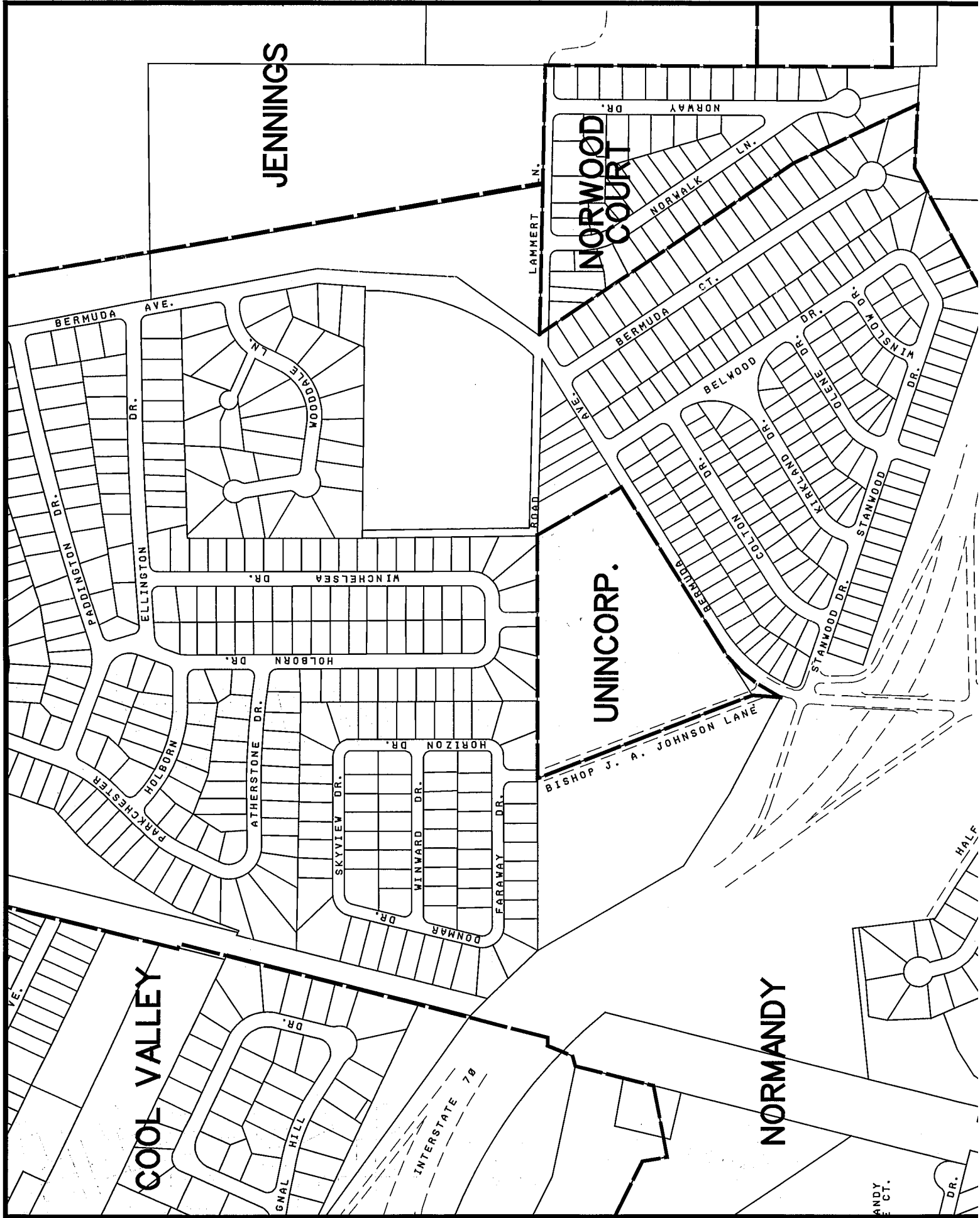
