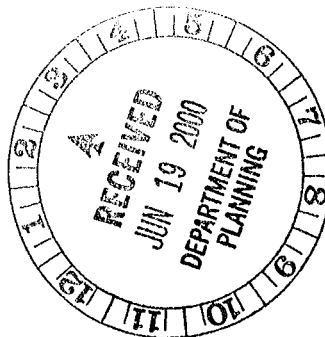


The official name of the party submitting the map plan to the Commission for review is Timothy G. Pickering, City Manager, City of Olivette.



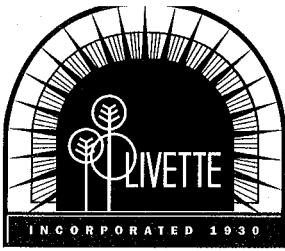
