Dear Mr. Wojtkowski:

Enclosed you will find a boundary map that has several changes noted. The original boundary map submitted by the City of Overland does not show Elmwood inside our boundaries due to an oversight on our part. The City of Overland is very interested in acquiring Elmwood either now or at a future date.

Another noted change is the Midland Boulevard boundary. Our Mayor, Bob Dody, and the Mayor of the City of St. Ann, Claude Buchheit, have held discussions and came to a mutual agreement that Midland Boulevard (the centerline) be the boundary between our two cities.

Lastly, I would like to bring to your attention a change at Lindbergh Boulevard (The South West portion of the boundary map). The City of Overland feels the center of Lindbergh Boulevard would be a more natural boundary.

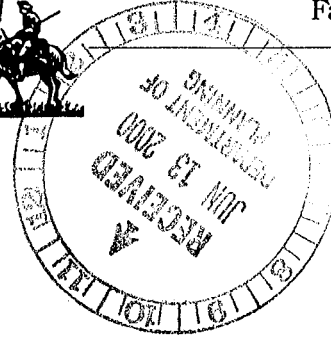
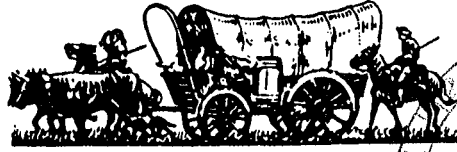

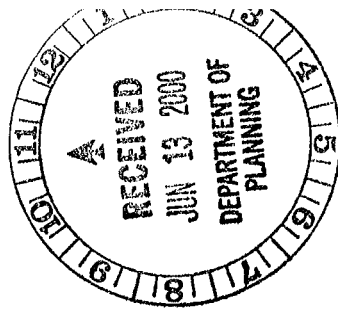
