

Re: July 1st, 2000 Proposed Boundary Adjustment Map Submission

Dear Mr. Krasnoff:

Enclosed please find a copy of the proposed boundary adjustment map submission for the City of Shrewsbury which is due July 1st, 2000. As you will note, the City of Shrewsbury indicates a proposed area to be considered for annexation by shading a segment of unincorporated area from our Watson Road municipal boundary south to Gravois Road, bounded to the east following the St. Louis City boundary, and bounded to the west to the point which skirts or abuts the municipal boundaries of the Village of Marlborough, the City of Crestwood and the Town of Grantwood Village.

Additionally, please note that per the Map Plan Submission – Information Sheet and the Missouri Revised Statutes, Chapter 72, §72.150 - .220 and §72.420, nothing has been indicated in terms of a potential consolidation with other surrounding municipalities on this map.
