In accordance with Article III of the Rules of the Boundary Commission, St. Louis County and RSMo §72.423, the City of Wildwood, Missouri is presenting its "map plan" as part of the Commission's first five year planning cycle. The City elected to submit its map plan in paper format as allowed for by the Rules. The paper submission has been prepared based upon the most recent digital version of the St. Louis County base map. If further or expanded detail is necessary, the City will be more than happy to provide any additional information.

The boundaries of the area included with the map plan include the following:

- on the north and east a natural ridge line, generally extending from Kiefer Creek Road on the north to the Meramec River on the south
- on the south, the northern bank of the Meramec River, which is consistent with the City's current boundary further to the west
- on the west, the City's current municipal boundary, and that of the City of Ellisville

on the north, the City of Ellisville's municipal boundary, the western right-of way line of a portion of Kiefer Creek Road at the intersection of Kiefer Creek and St. Paul Roads

The City's "map plan" area includes the rights-of-way of all streets and roads, with the exception of the intersection of Kiefer Creek Road and St. Paul Road. At that location, the boundary of the "map plan" extends to the western and southern right-of-way line of Kiefer Creek Road as it meets the northern terminus of the right-of-way for St. Paul Road.

## RESOLUTION #2000-20

A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO FILE WITH THE BOUNDARY COMMISSION OF ST. LOUIS COUNTY, A "MAP PLAN" IDENTIFYING THE LIMITS OF ANY POSSIBLE BOUNDARY CHANGES WHICH MAY OCCUR DURING THE FIVE-YEAR PLANNING CYCLE IN THE CITY OF WILDWOOD.

Whereas, effective January 1, 2000 RSMo §72.423 requires all municipal boundary changes and unincorporated area proposals except those affecting consolidations and transfers of jurisdiction, in St. Louis County, are subject to the regulations of the Boundary Commission, St. Louis County, and a five-year planning cycle, and

Whereas, as of May 1, 2000 the Boundary Commission, St. Louis County established rules and procedures necessary for implementing the five-year planning cycle, and

Whereas, as a prerequisite to the submission of any covered boundary change proposal, is the timely submission by the City of a "map plan" identifying the limits of any possible boundary changes which may occur during the five-year planning cycle, and

Whereas, the City of Wildwood has determined it to be in the best interest of the City of Wildwood and the residents of unincorporated St. Louis County that adjoin the City of Wildwood to preserve the opportunity to consider proposals for future boundary changes by submitting to the Boundary Commission, St. Louis County, a "map plan" in accordance with RSMo §72.423,

Now Therefore Be It Resolved that the City Administrator is directed to file with the Boundary Commission St. Louis County, a "map plan" which is attached hereto as Exhibit "A", and

Further, that in accordance with the Rules of the Boundary Commission, St. Louis County Article III.A.4.b the City Administrator is hereby identified as the City's designated representative, and

Further, that a copy of this resolution shall accompany the submission of the "map plan" as certification that this is the City's official "map plan" in conformance with the requirements of RSMo §72.423 and Rules of the Boundary Commission, St. Louis County Article III.A.4.c.

This Resolution shall be effective upon its approval.
