**WHEREAS**, the St. Louis County Boundary Commission had developed a five-year planning cycle for all boundary changes within the unincorporated areas of St. Louis County; and


**WHEREAS**, the St. Louis County Boundary Commission has advised that all cities must submit a Map Plan to said Commission by July 1, 2000 in order to have any consideration for annexation in the next five years; and

**WHEREAS**, the Map Plan is a general Map Plan document outlining the maximum boundaries that the City may consider annexing by the Year 2005 and does not bind the City in any way; and


**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
