Dear Chairman and Commission Members:

The Village of Twin Oaks hereby submits for your acceptance the Village of Twin Oaks Annexation Map Plan in accordance with requirements of applicable Missouri Statutes RSMo. 72.423 and commission rules and procedures.

The areas identified in Twin Oaks map plan include an unincorporated area contiguous to Twin Oaks and a second unincorporated area adjacent to the first area. These are highlighted in detail on the enclosed map documents.

As of this writing, Twin Oaks has no timetable for accomplishing any annexation. Such decisions cannot be made at this juncture and must remain open pending expressed interest in annexation from the identified areas and the completion of fiscal and service provision feasibility studies.

Attached to this letter is a certified copy of Ordinance #366 approved by the Village of Twin Oaks Board of Trustees authorizing the submission of this annexation map plan.

AN ORDINANCE ADOPTING A FIVE-YEAR ANNEXATION MAP PLAN FOR THE VILLAGE OF TWIN OAKS

WHEREAS, Section 72.423 RSMo. Establishes a five-year planning cycle for boundary changes and procedures for submitting to the St. Louis County Boundary Commission a fiveyear map plan, the current Plan to be submitted prior to July 31,2012; and

WHEREAS, submission of said map plan is a statutory prerequisite to a request during said succeeding five-year period for an actual boundary change;

NOW THEREFORE BE IT ORDAINED by the Board of Trustees of the Village of Twin Oaks, St. Louis County, Missouri as follows:

- Section 1. The annexation map plan attached hereto as Exhibit "A" and incorporated herein by reference is adopted as the Annexation Map Plan for the Village of Twin Oaks.
- Section 2. The Village Administrator/Clerk is directed to submit the Annexation Map Plan to the St. Louis County Boundary Commission for review and comment.
- This Ordinance shall be in full force and effect from and after its passage Section 3. as by law provided.


