

Resolution

City of Ballwin, Missouri

A resolution designating the unincorporated land area in which the City of Ballwin may pursue annexation within the 5-year period beginning April 15, 2001.

WHEREAS, the Boundary Commission of St. Louis County, Missouri, has been duly constituted and empowered to review annexation proposals within St. Louis County, Missouri, by the State Legislature; and

WHEREAS, the Boundary Commission of St. Louis County, Missouri, has required the submission of an Annexation Map Plan from all municipalities within St. Louis County wishing to consider annexation within the 5-year period beginning on April 15, 2001; and

WHEREAS, any City not submitting an Annexation Map Plan will be precluded from pursuing any annexation within said 5-year period; and


WHEREAS, the City of Ballwin wishes to reserve the option of pursuing annexation within said 5-year period.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF BALLWIN THAT:

1. A map plan be submitted to the St. Louis County Boundary Commission prior to July 1, 2000.
2. The submitted map plan shall be identical to the map plan attached hereto as Exhibit "A".

THIS RESOLUTION HAVING BEEN DULY CONSIDERED AND VOTED UPON BY THE BOARD OF ALDERMEN OF THE CITY OF BALLWIN, WAS PASSED AND APPROVED THIS 26 DAY OF June, 2000.
