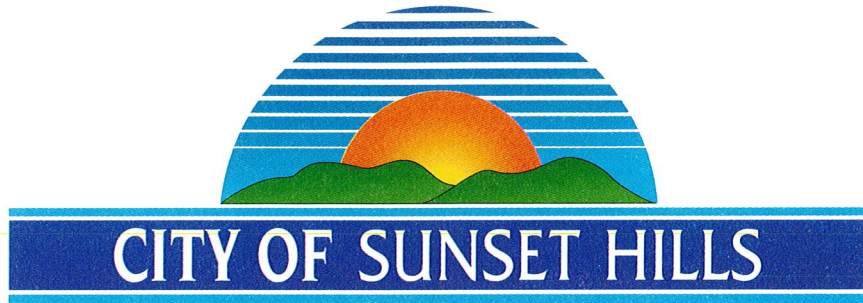


Re: Submittal of Map of Proposed Boundary Changes


