RE: Map Plan Submittal

Dear Boundary Commission Members:

On behalf of St. Louis County, I am officially submitting the County's map plan in conformance with Section 72.423 RSMo 1999. There are a total of five maps submitted for the Commission's review: 1) St. Louis County Map, 2) North County Map, 3) South County Map, 4) Mid-County Map, and 5) West County Map.

The County's map plan depicts proposed established unincorporated areas, including the Lemay Unincorporated Zone Proposal, BC9904, which was pending before the Boundary Commission on June 14, 1999 and the Parker-Halls Ferry Unincorporated Zone Proposal, BC9817, approved by the Boundary Commission as described in the Summary of Decision of March 2, 1999, but not yet placed on the ballot for voter approval. Additionally, the County's map plan shows unincorporated areas with populations under 2,500 for which the County currently provides services and is willing to continue to provide services in the future.

I have designated Mr. Glenn Powers, Director of Planning, as the person with the authority to act on my behalf with respect to the County's map plan. Mr. Powers can be contacted as follows:


Further, I hereby certify that the accompanying map plan represents St. Louis County's official map plan proposal in conformance with the requirements of Section 72.423 RSMo 1999.

Finally, I would like the Commission to be aware that St. Louis County officials are

currently in the process of identifying strips of unincorporated rights-of-way in municipal areas which are suitable for boundary adjustments. These unincorporated rights-of-way impede the effective and efficient delivery of public services and St. Louis County would like to transfer jurisdiction to municipalities. Under separate correspondence, Mr. Powers will be submitting maps of these proposed boundary adjustments to the Commission for informational purposes. Although boundary adjustments do not come under the review authority of the Boundary Commission, we believe it is important for the Commission to be aware of these discrepancies as you scrutinize proposed boundaries during the next several months. Through technical adjustments of map plan boundaries and future annexation proposals, there may be opportunities to rectify these discrepancies.
