ORDINANCE NO. 5944

AN ORDINANCE WITHDRAWING THE PROPOSED ANNEXATION OF THE CITY OF FLORISSANT, MISSOURI OF AN AREA OF UNINCORPORATED LAND DESCRIBED HEREIN AND REFERRED TO AS "DUNN ROAD-AREA 19" AND DIRECTING THE CITY ATTORNEY TO FORWARD A COPY OF THIS ORDINANCE TO THE ST. LOUIS COUNTY BOUNDARY COMMISSION.

WHEREAS, pursuant to Ordinance No. 5846, the Florissant City Council passed and approved an ordinance seeking the annexation of a certain area of unincorporated land, lying generally to the south and east of the existing limits of the City of Florissant and commonly referred to as "Dunn Road-Area 19", all of which is more fully described in Exhibit 1 attached hereto and made a part hereof (hereinafter referred to as "Annexation Area"), and

WHEREAS, pursuant to the process for reviewing annexation proposals, the City of Florissant provided the St. Louis County Boundary Commission with the official submittal for annexation of the Annexation Area; and

WHEREAS, some residents within the Annexation Area have expressed a willingness to consent to the annexation as a simplified boundary proposal; and

WHEREAS, the Council of the City of Florissant believes it to be in the best interest of all parties to pursue the possibility of a simplified annexation proposal and in so doing, believes that it is appropriate to withdraw the annexation proposal for the Annexation Area pending before the St. Louis County Boundary Commission.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FLORISSANT, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

Section 1: The City Council of the City of Florissant herein withdraws the annexation proposal for the Annexation Area and directs the City Attorney to advise the St. Louis County Boundary Commission of this withdrawal by providing a copy of this Ordinance herein.

Section 2: This Ordinance shall be in full force and effect immediately upon its passage and approval.






