She also explained that Manchester's application fee sufficiently covered the costs of processing their proposal. Ms. Dougherty said that the \$1/resident application fee is non-refundable. Ms. Dougherty stated that Alobar's reduced their bill by \$450 due to the livestreaming/recording error and she applied those savings to Normandy and Glen Echo Park's bill.
