## RESOLUTION NO. 2024 - 3

A RESOLUTION BY THE CITY OF PAGEDALE, MISSOURI AUTHORIZING THE MAYOR TO FILE WITH THE BOUNDARY COMMISSION OF ST. LOUIS COUNTY A MAP PLAN IDENTIFYING THE LIMITS OF ANY POTENTIAL BOUNDARY CHANGES THAT MAY OCCUR DURING THE UPCOMING FIVE-YEAR PLANNING CYCLE ESTABLISHED BY THE BOUNDAY COMMISSION.

WHEREAS, pursuant to Section 72.423 of the Revised Statuses of Missouri, there is established a five (5) year planning cycle for all municipalities to conduct annexation activities and stipulates that certain guidelines must be met within this five (5) year timeframe;

WHEREAS, in the period between January 1, 2024 and July 1, 2024, municipalities may present to the Boundary Commission of St. Louis County Map Plans of boundary changes for review; and

WHEREAS, the submission of a Map Plan does not obligate such municipality to pursue such a boundary change; and

WHEREAS, the City of Pagedale wishes to file a Map Plan submission for future potential boundary changes.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERPERSONS OF THE CITY OF PAGEDALE, MISSOURI AS FOLLOWS:

**SECTION 1.** That the Mayor of the City of Pagedale, Missouri is authorized to file with the Boundary Commission of St. Louis County the Map Plan attached hereto as Exhibit. Said Map Plan shall be filed on or before July 1, 2024.

<u>SECTION 2.</u> That this Map Plan represents the City of Pagedale's official Map Plan in conformance with the requirements of Section 72.423 of the Revised Statutes of Missouri.
