LOUIS COUNTY, MISSOURI AS FOLLOWS: 18 19 SECTION 1. Pursuant to RSMo §§ 72.400—72.433, the City Council hereby adopts 20 the Map Plan, attached hereto as Exhibit A and incorporated herein by this reference, as 21 the Map Plan of the City of Black Jack for submission to the St. Louis County Boundary 22 Commission. 23 24 SECTION 2. The City Council hereby authorizes and directs the Mayor of the City 25 of Black Jack to submit such Map Plan to the St. Louis County Boundary Commission and 26 to act on behalf of the City of Black Jack in transactions with the St. Louis County 27 Boundary Commission related to the potential annexation of the areas depicted on the 28 Map Plan. 29 30 SECTION 3.
