The manner which the email came in; the email address appeared to be misspelled as it was just slightly different than the sender's name. Ms. Dougherty reached out by telephone to confirm the identity. She never received a reply. She sent an email to the reply address asking for confirmation that they, in fact, sent the sunshine request.

After consulting with counsel and Chairman Mooney, the Commission responded to the Sunshine request to the reply email stating that there were no records that matched their request. The Commission sent that email within the statutorily defined response time.

Several days after Commission's Sunshine Request, the original sender replied to the FIRST email and explained away the discrepancies.
Ms. Dougherty has had no further interaction with the requestor.
